ARTICLE 2:

 - e) They accept, declare and undertake that they do not misstate and give deceptive or wrong information about their current situation,

THE SUBJECT OF THE AGREEMENT

ARTICLE 3:

The subject of this Agreement; is the that COMPANY is to perform the inspection services tendered to the COMPANY by the CUSTOMER in accordance with the attached "Terms and Conditions", within the framework of the Declaration of Independence, Impartiality, Integrity, Confidentiality, in accordance with the principles determined below.

AGREEMENT'S ANNEXES

ARTICLE 4 :

Prepared by the COMPANY; "Terms and Conditions" and "Declaration of Independence, Impartiality, Integrity, Confidentiality" are annexes and inseparable parts of this agreement.

OBLIGATIONS OF THE COMPANY TO PROVIDE THE SERVICE

ARTICLE 5 :

The COMPANY is obliged to perform the inspection services exact, flawlessly and completely within the framework of the CUSTOMER's work order and the principles, conditions and annexes specified in the Agreement.

While performing the inspection services, the COMPANY is obliged to choose the personnel it employs well among those with legal qualifications, and to show all necessary care in instruction and supervision.

The COMPANY is liable due to faulty or incomplete performance of the inspection services, or not performing as nothing at all or properly, without the need for any request or notice of the CUSTOMER.

OBLIGATIONS RELATED TO THE CUSTOMER

ARTICLE 6 :

The CUSTOMER agrees and undertakes to pay a fee to the COMPANY as specified in the price offer in return for the COMPANY to perform the inspection services defined in this Agreement to the CUSTOMER.

FORCE MAJEURE

ARTICLE 7 :

Force majeure is an event that develops beyond the control of the related party, except for negligence or fault, and prevents the performance of the SERVICE, and will be immediately notified to the other party in writing. In this case, the debts of the parties will be suspended, and if the force majeure continues for 30 days, the contract will automatically terminate at the end of this period.

NOTIFICATION ADDRESSES

ARTICLE 8 :

Unless the address change is notified to the other party in accordance with the law, notifications made to the addresses shown in the web-sites and correspondence are binding on the parties.

DOCUMENTS TO BE MUTUALLY DELIVERED

ARTICLE 9 :

The COMPANY will be submitted its report to the CUSTOMER as a result of the completion of the inspection services.

ENTIRE AGREEMENT

ARTICLE 10 :

Except as expressly stated in this Agreement, neither Party has made any promise, commitment or similar statement to the other Party to sign this Agreement. This Agreement, including this provision, cannot be amended unless signed by each Party.

PRICES

ARTICLE 11:

COMPANY accepts and undertakes to do the work at the prices specified in the attached offer. COMPANY can not charge additional fees in any way. Prices are fixed. These prices consist of labor, taxes, insurance, food, travel, etc. includes wages and general expenses and profit.

Value-added tax (VAT) is included in the prices.
